

Active mining claims within the Sheep Creek area have been held by U.S. Critical Materials (USCM) since 2022. Access to the area is via Forest Service (FS) Roads 5677 and 13862. claimants were not present. There are 3 historic adits where sampling and surveying are occurring under the claimant's current Notice of Intent (NOI). Closeout of NOI work is expected on or before October 24, 2025. Two adits are currently open, the third has not been reopened to date although there's been interest from USCM to reopen adit #2 with hand tools if possible. Adits remain stable and sites were clear of garbage however adit #3 had a blue tarp laying in the entrance. Previous discussions (05/24/2023) with USCM's consultant Peter Mejstrick contemplated the need for bat gates on the adits once a Plan of Operations has been submitted. None of the adits are visible from open FS roads.
